WHERE: Settle in for eight nights at a beautiful villa hotel near Perugia, Umbria's lively capital—no packing and unpacking!

TRIP LEADERS: Cal Fortbrook, acclaimed watercolorist, professor of art and instructor at the Naples Art Association, and **Christine & John Stewart**, art historians, travel virtuosi, and founders of Stewart & Hunnisett, Fine European Touring. Chris and John have been designing and leading trips for over twenty-five years and are Italy experts (John was raised in Rome). Cal and the Stewarts have joined forces in the past on highly successful trips for the Athenaeum Music & Arts Library in La Jolla, California.

DO I HAVE TO BE AN ARTIST TO PARTICIPATE? Not at all! This trip provides a rich range of activities which will appeal to sketchers and non-sketchers alike. Our daily excursions include visits to some of the most wonderful art cities in Umbria and Tuscany, short walks, and time to explore hilltop towns and immerse yourself in your magnificent surroundings. The trip is open to everyone in the Naples Art Association community, their families and friends. It is limited to 26 participants and a portion of the cost includes a donation to the NAA.



Itinerary

Sunday, June 25—Rendezvous in Rome. The charms of Orvieto and arrival in San Martino in Campo.

Meet at 9:00 a.m. in the lobby of the Sheraton Parco de' Medici hotel, located midway between the airport and downtown Rome, and board our private coach for a drive through the picturesque Tiber Valley to Orvieto in southwestern Umbria. This charming medieval hilltown is perched high atop steep cliffs and surrounded by vineyards that yield its fabulous white wines. We'll visit the town—so many treasures!—and take in the sensational views from the old clock tower (the countryside seems as if freshly painted by one of the masters). After lunch, continue north to San Martino in Campo and our hotel, the Posta dei Donini, our Umbrian home. Settle in, explore the beautiful grounds, and meet later for an *aperitivo* before our welcome dinner. (L, D).

Monday, June 26-Perugia, Umbria's lively capital.

Perugia got its start as an Etruscan center and in due course became a Roman town and then a powerful medieval city. Highlights here include magnificent frescoes by Renaissance master Perugino who is the town's most illustrious son (Raphael was for a brief time one of his pupils), the stupendous Fontana Maggiore which is one of Europe's most elaborate medieval fountains, and the vast cathedral. Perugia is worldfamous for its Baci Perugina (the delectable foil-wrapped chocolates) and we'll sample a few when we pause for a mid-morning cappuccino. Sketch, paint, or shop along the cosmopolitan Corso Vannucci-the town's main pedestrian thoroughfare-and also venture into the smaller medieval streets in the heart of town. Many will want to visit Umbria's superb National Gallery of Art with the Stewarts and see the top works, gliding from masterpiece to masterpiece. Return to San Martino in Campo and relax-a swim, a spa treatment, a quiet time in the garden? (B, D)

Tuesday, June 27—Picture-perfect Todi and the colorful ceramics of Deruta.

Social scientists have claimed that Todi has Europe's highest quality-of-life index, and it's not hard to see why as we savor *la dolce vita* this morning around the main



square—calling all sketchers and painters! One of Italy's most spectacular Renaissance pilgrimage churches, Santa Maria della Consolazione, is nestled on Todi's hillside and visible from miles away. Many scholars believe Leonardo da Vinci had a hand in its design—what a glorious arrangement of billowing white stone! On our way home, we'll pause at the hilltown of Deruta, known for centuries for its exquisite ceramics. (B, D)

Wednesday, June 28—Gubbio, an Umbrian gem.

Gubbio, set against a mighty mountain, is where St. Francis miraculously tamed a ferocious wolf that was terrorizing the inhabitants! The Ducal Palace is a testament to the refined ambience of the Duchy of Urbino, once one of Italy's finest small city states and a magnet for Renaissance artists and architects. Choose a picturesque streetscape—what a delight for mind, eye, and hand! Non sketchers may wish to join the Stewarts for a ride on the *funivia* (funicular) to the top of Monte Ingino and the Basilica of St. Ubaldo (Gubbio's patron saint, who was buried here in 1194). Those who wish can set off with the Stewarts on a beautiful walk back down into town along a wide unpaved road (nonwalkers can simply return to town by *funivia*). (B, D)



Itinerary

Thursday, June 29—Assisi and the legacy of St. Francis with a visit of his hermitage. An insider's tour of the Basilica of St. Francis.

On our way to Assisi, we'll see the *Porziuncola*, the tiny stone church where St. Francis and his followers first worshipped (it is now enshrined in a vast church, the Papal Basilica of Santa Maria degli Angeli). Before heading into town, we'll visit the Eremo delle Carceri on a high cliff where Saint Francis and his companions went to pray and meditate. Marvel at Assisi's lovely main square which has a perfectly preserved Roman temple front! So much to enjoy for sketchers and non-sketchers alike! This afternoon we visit the Papal Basilica of St. Francis with a Franciscan brother for a true insider's tour of this astonishing complex filled with monumental fresco paintings by Cimabue, Giotto, Simone Martini and Pietro Lorenzetti. Friday, June 30—Montepulciano and the estate of La Foce.

Montepulciano is renowned for its *Vino Nobile*, one of Italy's best reds, and its main street is lined with stately Renaissance palaces. We'll visit the chilly, cavernous chambers of a medieval wine cellar with its huge ancient barrels. Sketch, paint and get to know this intriguing town which prospered greatly during the 16th century. The pilgrimage church of San Biagio, set in a hillside just outside the town, is an outstanding Renaissance monument. We'll crown our first Tuscan day with a private visit of the estate of La Foce with its striking formal gardens that provide the perfect foil for the cypress and olive trees that surround us in the rolling Tuscan landscape. Saturday, July 1—Arezzo—Renaissance masterpieces and the renowned monthly open-air antiques market!

Today we continue our Tuscan explorations with Arezzo where Renaissance genius Piero della Francesca created the astounding fresco cycle of the *Legend of the True Cross* using his unique language of pure forms and luminous colors. Our visit includes the house of Giorgio Vasari, architect of the Uffizi in Florence and author of the *Lives of the Painters, Sculptors and Architects*, the first modern history of art (1550). Arezzo is a major antiques center and today we'll have a chance to peruse the outdoor antiques market, one of Italy's best (and it only happens once a month!). As always, picturesque streets and a gorgeous main square provide a treasure trove of subjects and vistas for sketchers, painters, and photographers! (B, D)

Sunday, July 2-Cortona, a Tuscan delight.

The Tuscan hilltown of Cortona, celebrated in recent years by bestselling author Frances Mayes, is the enchanting home to Fra Angelico's marvelous Annunciation of 1433-34, one of the Renaissance's most precious works. Absorb the atmosphere around the main square and admire the endless views of the countryside from the lookout on Piazza Garibaldi-what an ideal location for sketching and painting! You may wish to drop in on the venerable Etruscan Academy (founded by some enterprising young scholars in the 1720s), an eclectic museum that displays everything from Egyptian mummies to an elaborate Etruscan candelabrum! Other options include a walk to the upper reaches of the town and the Medici fortress, or a stroll outside the massive Etruscan walls. This evening gather for a special farewell dinner prepared by our talented chefs. (B, D)

Monday, July 3—Departure.

This morning after breakfast we transfer to Rome and the Sheraton Parco de' Medici hotel. (B)





Tour Leaders



Calvin Fortbrook earned his BA degree at Principia College, gained professional training at the Cleveland Institute of Art and received his MFA in painting at Cranbrook Academy of Art. His teaching posts included San Diego State University, California Western University (where he chaired the art department), the School of Preforming and Visual Arts of United States International University, and as the adjunct Professor at San Diego Mesa College. During his tenure at USIU, he taught in both the undergraduate and graduate programs and received an award of merit for Outstanding Achievement in Teaching and Service reflecting his numerous capacities as administrator, guest lecturer, juror and distinguished teacher.On a yearlong sabbatical

leave, Fortbrook chose the Costa Blanca area of Spain, plus Brittany and the southern coast of France for gathering painting material. He has conducted art workshops in England, France, Italy (Tuscany, Umbria, and Northern Italy), Sicily, and the US. His exhibitions and awards include Watercolor USA (Springfield, Mo), Watercolor West, Wichita Centennial Art Exhibition (purchase award), Butler Institute of American Art (all juried national exhibitions); one man exhibits at the Edward Dean Museum (CA), and the Minor Memorial Art Gallery (CT), San Diego Watercolor Society Golden State Exhibit, SDWS 4th Annual Exhibition (best of show), and Southern California Juried Art Exhibition (1st Place). Chris Stewart was raised in Toronto and educated at Branksome Hall, St. Mildred's Lightbourn School, the University of Western Ontario, the University of St. Andrews in Scotland (where she was the first woman to receive the McEuen Scholarship), the Università per Stranieri di Perugia and Columbia University in New York where she was a President's Fellow and completed all the requirements for a Ph.D. in art history with the exception of the dissertation, deciding in the mid-1990s to become an independent art historian in New York City and co-founding Stewart & Hunnisett with her husband John. As a Helena Rubinstein Fellow on the Whitney Museum's prestigious Independent Study Program (ISP), she co-curated the exhibition *Generations*

of Geometry shown at the Whitney's Equitable Center, and later worked for several years at The Museum of Modern Art in New York curating exhibitions of contemporary art for the corporate galleries of MoMA's major supporters. Her responsibilities at MoMA also included advising Fortune 100 executives on art purchases and site-specific commissions for their corporate headquarters and participating in the special acquisitions program for Room 5600, the Rockefeller family office at Rockefeller Center. She has been a visiting professor of art history at Principia College in Elsah, Illinois, and her areas of special study in the visual arts include Italian and French Renaissance and Baroque art and architecture, the English watercolor school, 20th century American art, the work of Joseph Cornell, and contemporary art.



John Stewart was raised in the heart of Rome, Italy, where his family resided for over two decades, and was educated internationally at Rome's Collegio San Giuseppe and St. Stephen's School, Trent University (Canada) and at the universities of Nantes, Paris (Sorbonne), Siena and Toronto where he completed all the requirements for a Ph.D. in art history with the exception of the dissertation, deciding in the mid-1990s to become an independent art historian in New York City and co-founding Stewart & Hunnisett with his wife Chris. For several years he worked at the National Gallery of Canada on a major international Edgar Degas retrospective in cooperation with the Musée d'Orsay in Paris and The Metropolitan Museum of Art in New York, and was

later guest curator of the exhibition *Prints from the Age of Rembrandt* at the Art Gallery of Ontario. John's interests in the visual arts range from Roman architecture to contemporary art and his areas of special focus include Italian Renaissance and Baroque art and architecture, Dutch and Flemish painting, French literature, art and architecture, and European history and culture from the Renaissance to the present day. He is entirely fluent in Italian and French and is an engaging public speaker whose talks on a variety of topics have attracted record audiences. He has lectured abroad for the Young Presidents Organization, was the Italian editor of *Melvin Charney/Krzysztof Wodiczko*, Canada's exhibition catalogue for the 42nd Venice Biennale, contributed to a Paris guidebook, and his translations include a guide by King Louis XIV to the Gardens of Versailles published by the National Museums of France. The Details

Practicalities:

- We meet on the morning of Sunday, June 25, at 9:00 AM in the lobby of the Sheraton Parco de' Medici Hotel, located midway between Rome's Leonardo da Vinci airport and downtown Rome.
- Participants arriving directly from the U.S. should plan to fly out at the latest on Friday, June 23, landing in Rome on Saturday, June 24.
- The Sheraton Parco de' Medici Hotel is a comfortable and reasonably priced four-star hotel surrounded by a 27-hole golf course and with an outdoor swimming pool. Participants who wish to stay here the night of June 24 can either book directly online or are welcome to contact the Stewarts who will be happy to assist with reservations. Those who choose to stay at another hotel in Rome on the night of Saturday, June 24, can simply take a taxi to the Sheraton Parco de' Medici Hotel in time for our Sunday morning departure for Umbria at 9:00 AM.
- The tour ends on the morning of Monday, July 3, with a transfer back to the Sheraton Parco de' Medici Hotel in Rome where we expect to arrive around noon.
